Refrigerator/Freezer and Microwave Oven Limited Warranties

Absocold Corporation is pleased to provide the following warranty in connection with its Cook 'N Cool® products, and guarantees that any of its combination appliances will be free from defects in materials and workmanship, for a period of **One Year for parts and labor** from the date of purchase, to the original purchaser only, when this Cook 'N Cool® product is operated and maintained according to instructions attached or furnished with the product.

In addition, the following components are warranted from defects in materials and workmanship:

A) Microwave oven magnetron

If the microwave oven magnetron should fail from defects in materials and workmanship during the **Second through Fifth year**, a new replacement microwave oven will be provided.

B) Refrigerator/Freezer Sealed System including the hermetic compressor

If the refrigerator/freezer sealed system or hermetic compressor should fail from defects in materials and workmanship during the **Second through Seventh year**, a new replacement refrigerator/freezer will be provided.

During the above warranty periods, Absocold Corporation and its authorized dealers, servicers and/or representatives retain the option to repair or replace each component or subassembly of the Cool 'N Cool®, free of charge, or to repair or replace the entire assembly free of charge, as deemed appropriate by Absocold, if installation is within the fifty (50) States or the District of Columbia. If installation is outside the fifty (50) states or the District of Columbia, the cost of installation and repair will be borne by the purchaser, and Absocold's warranty obligation hereunder shall be limited to furnishing replacement parts and materials, freight prepaid, to the continental U.S. port designated by the purchaser.

In an effort to properly administer its warranty policy, Absocold Corporation or its representatives may require a proof of purchase document (paid and dated receipt or invoice) before authorizing service or repair under this warranty. The warranty period defines on the date of sale as evidence by the original sales receipt or invoice.

Absocold Corporation assumes no liability whatsoever nor does it guarantee or warrant: any repairs or replacement parts not performed or supplied by an authorized service agent; damage or failure as a result of not following the instructions and procedures outlined in the owner's Instructions as provided with each appliance; damage caused by spark fires as a result of improper use of the microwave oven (using metal inside microwave); any alterations whatsoever to the Cook 'N Cool® appliances; and, failure or damage caused by misuse, neglect, fire, flood, accident or other acts of God.

Your Cook 'N Cool® complete model and serial numbers will be necessary before calling!
